THE APPOINTMENT / ABSORPTION WILL BE SUBJECT TO AVAILABILITY OF VACANCEIS, MEDICAL FITNESS AT THE TIME OF REPORTING FOR INDUCTION TRAINING AS WELL AS FOR REGULAR APPOINTMENT, SUCCESSFUL COMPLETION OF INDUCTION TRAINING, FULFILLING THE RECRUITMENT NORMS, SATISFACTORY VERIFICATION OF CHARACTER & ANTECEDENTS, VERIFICATION OF CASTE CERTIFICATE & VALIDITY OF CASTE CERTIFICATE, IF APPLICABLE AND REQUIREMENT OF OTHER GOVERNMENT DIRECTIONS FROM TIME TO TIME.

A SEPARATE COMMUNICATION WILL BE SENT THROUGH THE REGISTERED EMAIL IDS OF THE SELECTED CANDIDATES. MANDATORY E-SSQ AND E-AF FORMATS ALSO WILL BE REQUIRED TO BE FILLED AND SUBMITTED BY THE CANDIDATES.
4. THE SELECTED CANDIDATES WILL BE CALLED FOR SIX MONTHS INDUCTION TRAINING FOR THE POSTS OF JPA/JSK AT DPS, MUMBAI ONLY ON THE RECEIPT OF THEIR SURETY BOND AND AGREEMENT.
5. IF IT IS FOUND THAT ANY CANDIDATE IS NOT FULFILLING THE REQUIREMENT STIPULATED IN RECRUITMENT RULES, HIS / HER CANDIDATURE IS LIABLE TO BE TERMINATED / CANCELLED AT ANY TIME.
